

## **Fastest Lap Competition: Terms and Conditions**

### **The Promoter**

The Promoter is: Essar Oil (UK) Limited (trading as EET Fuels) of 5th Floor, The Administration Building, Stanlow Manufacturing Complex, Ellesmere Port, Cheshire, CH65 4HB (“we”, “us”, “our”).

### **The Competition Overview**

- 2.1 The title of this competition is “Fastest Lap Competition’ (the “**Competition**”).
- 2.2 The winners of the top three fastest lap times from all the Competition entries will receive:
  - (a) First Place: two tickets to attend midweek golf at Carden Park Hotel, Broxton Road, Nr Chester, Cheshire, CH3 9DQ, United Kingdom with members of our commercial team at a date of the winners choosing (subject to availability and between Monday to Thursday).
  - (b) Second Place: two tickets to the Porsche Carrera Cup GB Season rounds 9 and 10 at Donington Park, Castle Donington, Derby DE74 2BN on 20 to 23 August 2026.
  - (c) Third Place: one signed Tranmere Rovers football top.
- 2.3 Participants will use the EA Sports 2025 Formula One in one of two racing simulators (the “**Game**”).
- 2.4 Participants will use the Game’s official 2025 Formula One cars and race on the UK’s 5.891 km Silverstone Circuit (the “**Circuit**”).
- 2.5 Only lap times completed on the Circuit will be entered into the Competition.
- 2.6 The Promoter shall record the top fastest eligible Qualifying Lap times on a physical leader board that is displayed on or around the Promoter’s Conference stand.
- 2.7 Details of how to enter the Competition are set out below.
- 2.8 All reference to the “**Competition Terms**” shall be reference to these Fastest Lap Competition: Terms and Conditions which are set out within this document.

### **How to enter**

- 3.1 The competition will open at 09:00 GMT 15 April 2026 and will close 16:00 GMT 16 April 2026 (the “**Competition Period**”).

- 3.2 All Competition entries received before and after the Competition Period are automatically disqualified.
- 3.3 All participants must be attendees to The UKIFDA Expo & Conference (the “**Conference**”) during the Competition Period.
- 3.4 To participate in the Competition the Eligible Participant (as defined below) must:
- (a) on our electronic tablet or similar device (and subject always to clause 9):
    - (i) provide limited contact details to us (name, phone number, employer or company, email address, acceptance of these Competition Terms, your consent to us processing your personal data, and the Qualifying Lap Time);
    - (ii) Check the tick box to accept these Competition Terms; and
    - (iii) Check the tick box to give us consent to process your personal data, and
  - (b) complete one lap of the Circuit from a standing start (the “**Qualifying Lap**”).
- 3.5 A confirmation response stating that the submission has been received will be generated by our electronic tablet or similar device once an Eligible Participant has successfully submitted an entry.
- 3.6 An entry will be deemed valid only if it satisfies all the conditions under clause 3.4 and these Competition Terms.
- 3.7 We may check the validity of any entry and reserve the right to exclude any entries that are not compliant with these Competition Terms.
- 3.8 The Promoter will **not** accept responsibility for Competition entries that are incomplete or delayed, not accepted by the website form, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
- 3.9 The Promotor will not accept responsibility for the failure or malfunction of the simulator or related equipment. At the Promotor’s sole discretion, it shall determine the outcome of the Competition as fairly as possible in circumstances where there is a failure or malfunction of the simulator or related equipment.
- 3.10 By submitting a Competition entry, you agree to be bound by these Competition Terms.

### **Eligibility**

- 4.1 The Competition is only open to attendees of the Conference who are residents of the UK and aged 18 years or over, **except:**

- (a) employees of the Promoter or its holding or subsidiary companies;
  - (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the Competition or its administration; or
  - (c) members of the immediate families or households of (a) and (b) above.
- 4.2 Participants that meet the eligibility criteria set out in clause 4.1 shall be referred to as an **“Eligible Participant”**.
- 4.3 By entering the Competition, you confirm that you are eligible to do so and eligible to claim the Prize. The Promoter may require you to provide proof that you are eligible to enter this Competition.
- 4.4 Eligible Participants will be permitted to complete one Qualifying Lap. The Promoter may at its discretion, allow Eligible Participants to complete more than one Qualifying Lap.
- 4.5 Eligible Participants are permitted to enter the Competition multiple times during the Competition Period, at the Promoter’s discretion.
- 4.6 Competition entries cannot be transferred and any entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 4.7 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of this Competition or these Competition Terms.

### **The Prize**

- 5.1 The Competition has three prizes for the fastest, second fastest and third fastest Qualifying Lap times set by Eligible Participants (each individually and collectively referred to as **“Prize”**).
- 5.2 First Place Prize
- (a) The Eligible Participant with the fastest Qualifying Lap time will receive the First Place Prize;
  - (b) The first place prize is two tickets to attend midweek golf 4 ball at Carden Park Hotel with members of our commercial team at EET Fuels. The winner will be invited to bring one named guest and will be able to select any date of their choosing (subject to team availability and between Monday to Thursday, and in any event between 17 April 2025 to 05 February 2027);
  - (c) The tickets include the following:

- (i) the choice between two championship 18 hole golf courses, The Cheshire or the Nicklaus; and
- (ii) the use of a golf buggy whilst on the chosen course, and
- (d) The prize does not include transportation to and from Carden Park or overnight accommodation before or after the event or golf equipment.

### 5.3 Second Place Prize

- (a) The Eligible Participant with the second fastest Qualifying Lap time will receive the Second Place Prize;
- (b) The second place prize is two hospitality tickets to attend the Porsche Carrera Cup GB Season rounds 9 and 10 at Donington Park Circuit on the 23 of August 2026 as a guest of the Promoter. The winner will be invited to bring one named guest;
- (c) The hospitality tickets include the following:
  - (i) all day access to watch the racing at Donington Park Circuit;
  - (ii) access to an exclusive hospitality unit (which provides a base, all day complimentary refreshments and food); and
  - (iii) a visit to the Team Parker Racing hospitality area including drivers meet and greet, and opportunity to sit in the car and take photos, and
- (d) The prize does not include transportation to and from Donington Park Circuit or overnight accommodation before or after the event.

### 5.4 Third Place Prize

- (a) The Eligible Participant with the third fastest Qualifying Lap time will receive the Third Place Prize;
- (b) The third prize is one Tranmere Rovers F.C football top signed by the 2026 EFL League Two men's first team; and
- (c) Once a winner is contacted, the Promoter will organise for delivery to a place of the winners choice or collection from Stanlow Manufacturing Complex.

5.5 The winners of the First Place Prize, Second Place Prize, and Third Place Prize shall be referred to as the “**Winner(s)**”.

5.6 The Promoter reserves the right to make changes to the Prizes without notice.

5.7 The Prize is not negotiable or transferable. There is no cash alternative for the Prize.

### **Claiming the prize**

- 6.1 Only each Eligible Participant's single fastest Qualifying Lap time will count as an entry towards the Competition, and the other lap time(s) shall be disregarded. For the avoidance of doubt, the Winner cannot claim more than one Prize.
- 6.2 If for any reasons the Winner is unable to take up their Prize, at the Promotor's sole discretion, the fourth fastest Qualifying Lap will be offered the rejected Prize. This will continue, at the Promotor's so discretion, with the fifth, sixth, and seventh fastest Qualifying Laps until the relevant Prize is accepted by a Winner.
- 6.3 If you are a Winner of the competition, you will be contacted after the Closing Date by telephone, voicemail and/or email.
- 6.4 You will have forty-eight (48) hours after this initial contact by the Promoter to confirm your acceptance of the Prize by telephone, voicemail and/or email.
- 6.5 If you do not claim the Prize in the manner laid out in this clause 6 within the required timescale, your claim to the Prize may become invalid and we reserve the right to select another substitute Winner.
- 6.6 The Prize may not be claimed by a third party on your behalf.
- 6.7 The Promoter does not accept any responsibility if you are not able to take up the Prize for any reason.
- 6.8 The decision of the Promoter as to the Winners is final and no correspondence or discussion will be entered into.
- 6.9 The Promoter will contact the Winners after the Competition Period using the details submitted by the Winners under clause 3.4.

### **Limitation of liability**

- 7.1 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss or damage occurring as a result of taking up the Prize. Your statutory rights are not affected.

### **Ownership of competition entries and intellectual property rights**

- 8.1 The Promoter does not claim any rights of ownership in your competition entry.

- 8.2 By submitting your Competition entry and any accompanying material, you agree that the Promoter may, but is not required to, make your entry available in connection with any publicity of the Competition, or to disclose to the authorities if challenged.
- 8.3 By submitting your Competition entry, the winners agree that the Promoter can use your (and your guest's, if applicable) name and photograph for the Promoter's marketing purposes.

#### **Data protection and publicity**

- 9.1 The Promoter will only process your personal information as set out in the Promoter's Privacy Notice: <https://www.eetfuels.com/privacy-policy/>.
- 9.2 Your consent is required for the processing of your personal data in connection with this Competition. Without your consent, we are unable to administer the competition and you will not be able to participate. Please refer to Consent and Privacy Notice above for details.
- 9.3 You consent to your personal data being processed for the purposes of administering this Competition, marketing purposes, and to be displayed on or around the Promoter's stand during the Conference.
- 9.4 The Promoter will retain any personal data in its Customer Relationship Management (CRM) system and all personal data will be retained in accordance with the Promoter's data retention policy and, in any event, for a reasonable period.

#### **General**

- 10.1 If there is any reason to believe that there has been a breach of these Competition Terms, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the Competition.
- 10.2 The Promoter reserves the right to hold, void, suspend, cancel, or amend the Prize Competition at its sole discretion.
- 10.3 These Competition Terms shall be governed by English law, and the parties submit to the exclusive jurisdiction of the courts of England and Wales.
